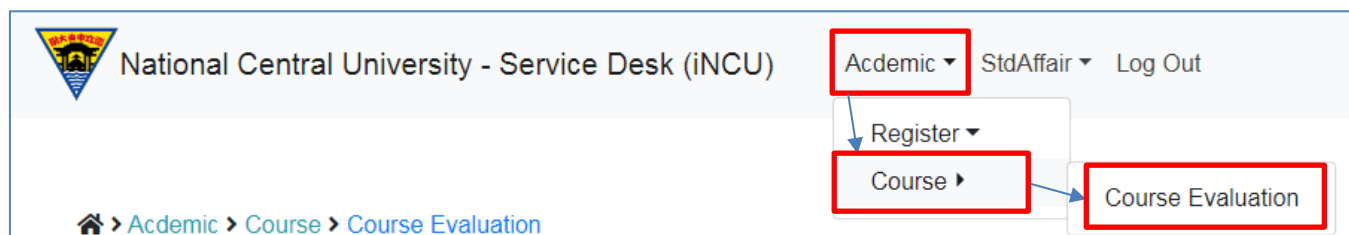
1. Type in your Account Name and Password and click the Login button.

(1) **NCU students** enter **Portal account** and **password**

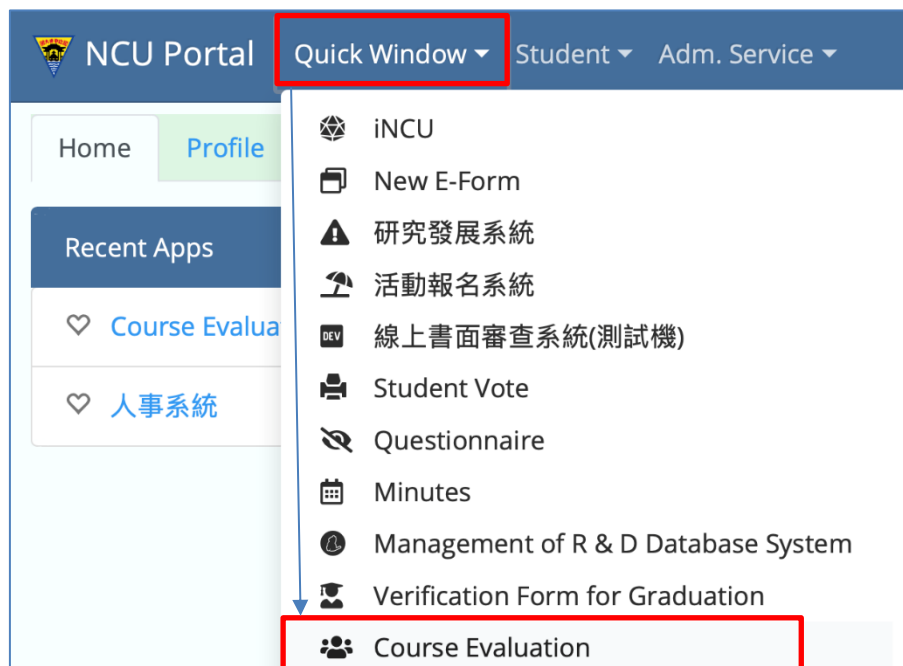
(2) **Non NCU students** enter **Net ID account (email address)** and **password**

2. Two access links to Course Evaluation system :

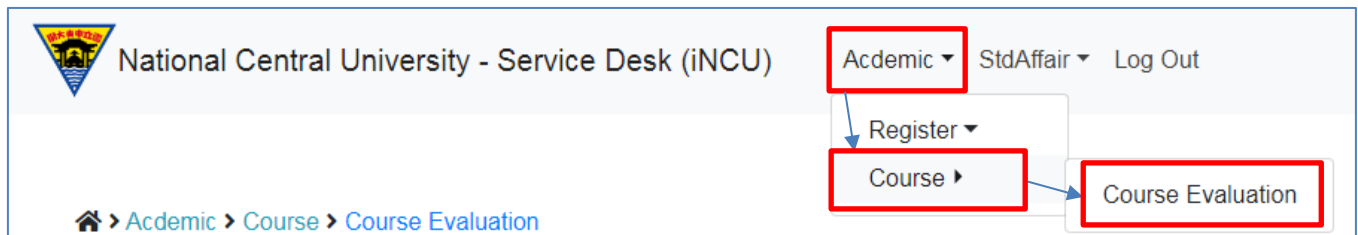
